PROJECT SUMMARY

Attached is the Draft Work Plan to support a Removal Site Evaluation (RSE) at Pier Dump Site (Site LP24) at Bellows Air Force Station and Marine Corps Training Area, Oahu. The RSE is required due to the Pier Dump Site is suspected to have been subjected to the historic release of hazardous contaminants. It will provide sufficient information for the U.S. Air Force and the State DOH to determine the following:

1. If the site poses an unacceptable risk to human health and/or if further remedial action is required
2. No further response action required.

Please note that we have previously commented to the Installation Restoration Program, which the subject document supports and is a part of. As a result, we will not comment to the subject document.
