9	Area between Revetments 32 and 33 designated "coral pit," several revetments in this area excavated by 1966 and the area is designated "dump area" through 1975	after 1955 - at least 1975	drums; other waste unknown	drawings from December 1955; May 1957; August 1966; April 1969; December 1975
10	"Surplus fill" from "rough clearing and grading" dumped here in 1957; this area designated "trash dump area" on maps through 1969	by 1957 - at least 1969	municipal waste; landscaping debris; metallic debris; drums; concrete debris; treated wood; transformer casings	drawings from May 1957; August 1966; April 1969
11	This area designated "dump area for asphaltic concrete and coral" on 1969 map	by 1969 - unknown	asphaltic concrete and coral	April 1969 drawing: "Install Fire Hydrants, Bellows AFS, Hawaii"

* Historical documents do not address the disposal of potentially hazardous wastes from military operations during World War II. It is possible that industrial wastes may have been disposed of in any of the above-referenced dump sites.
